

Use of Artificial Intelligence on the website of the Network

The purpose of this page is to explain in a transparent manner how artificial intelligence (AI) systems are used on the network-presidents.eu website.

The AI systems used by the Network are implemented in accordance with the European Regulation on Artificial Intelligence (EU AI Act) and the General Data Protection Regulation (GDPR).

1. Use of artificial intelligence on network-presidents.eu

The network-presidents.eu website uses artificial intelligence systems only for the automatic translation of documents (court judgments) retrieved through the Common Portal of Case Law.

The documents retrieved via the Common Portal are automatically translated using a neural translation system based on artificial intelligence.

The objectives of implementing automatic translation are:

- To improve access to case law of European Supreme Courts,
- To help overcome legal research limitations resulting from language barriers.

Please note that the AI translation system used may generate errors, inaccuracies and/or approximations. Automatic translation is not a substitute for professional human translation.

2. Warning regarding the reliability of automatic translations

The automatic translations published on this site are provided for information purposes only. AI generated translations:

- May contain errors, omissions or incorrect interpretations,
- Do not constitute official translations,
- Have no legal effect.

In the event of discrepancies, the original version of the document shall prevail.

Each page containing an automatically translated document includes an explicit reference to the use of an AI system.

3. Transparency required by the EU AI Act

In accordance with Article 50 of the EU AI Act, the Network informs users that the translations generated automatically on this website are produced by an AI system.

This content is identifiable as such by means of visible notices and, where applicable, technical metadata indicating its "AI-generated" origin.

The network-presidents.eu website does not deploy any high-risk AI systems as defined by the AI Act.

4. Data processing and compliance with the GDPR

In the context of the use of artificial intelligence, the Network strictly complies with the GDPR:

- No personal data is processed for the purpose of training or improving the AI system.
- Should a legal document contain personal data (name, address, position, etc.), this data is reproduced solely for the purposes of its legitimate publication or translation.
- No personal data is sent to third-party providers that do not comply with European regulations.

The Network follows the principles of data minimization, security and storage limitation.
